



Pub to Pub Walk - Terms & Conditions

Event Date

Saturday 10th August 2024

Registration

I agree that when completing the registration form, I am acting as myself and providing true information. I am personally responsible for any name change, address change or other relevant data changes. I agree that all emergency contact and medical information provided is true and I am happy for these to be shared with medical teams on the day of the event. I agree that if any misleading or incorrect information is provided to Dove House Hospice, they shall not be liable for death, personal injury or loss or damage as a consequence of participation, except with regard to personal injury arising as a result of the organiser's negligence.

Event Start

I agree that the organiser retains the right to change the start time if the expected capacity of the event is exceeded. In the event that this happens, I am happy to participate in a staggered start time, or potentially an alternative starting location. Please note that this will not affect the participant's activities on the day as this is not a timed event.

Cut-Off Times

I agree to complete the Pub to Pub Walk and cross the finish line at Humber Bridge Country Park - Upper Car Park by 7pm to ensure I am able to walk safely in daylight hours, otherwise it is at my own negligence and safety.

Event Cancellation and Refunds

I agree that, should the event be cancelled and a suitable alternative date cannot be arranged, my registration fee shall be donated to Dove House Hospice.

Leaving the Event

If I, or any of my party leave the Walk at any time or do not check in at the designated pubs and do not notify the organisers, I am responsible for my own health and wellbeing and accept that Dove House Hospice will not be liable for any injury, damage or death. Please note, all individuals will receive a pre-event briefing stating the check in points, a route map, emergency contact numbers/procedures and advice for all walkers in staying safe.

Unacceptable Behaviour

I understand that the event is raising money and awareness in support of Dove House Hospice and other local charities. Any inappropriate behaviour could result in a negative reputation for these charities which may affect future events and income. I agree to act appropriately at all times.

Risks

I acknowledge that there may be risk, circumstances or conditions on the day that are beyond the control of the organiser. Dove House Hospice has created a detailed and comprehensive risk assessment for the event to ensure the utmost safety for individuals. Whilst vehicles are welcome to be left in the upper car park of Humber Bridge Country Park overnight, please note that this will be at the owners risk and liability.



Children

It is advised that entrants do not bring children under the age of 18 due to the nature of the Walk.

Health and Fitness

I agree that I am in satisfactory health and see myself as physically fit to participate. Should I not see these two factors as being classed as 'good', I understand it is my responsibility to consult my GP. If I choose to take part, it is at my own negligence.

I can confirm that all medical information and prescribed medication outlined by myself on the registration form is true and I consent to these details being passed on to the medical team and first aiders on the day. The event is classed as low risk; however, we have ensured adequate stops and rest points along the route.

Dogs

I understand that if I bring a dog, it will be on a lead at all times. I will clean up after them and provide adequate water and food. I accept that pub check points on the route may not accept my dog into their premises.

Clothing

I understand it is my responsibility to wear appropriate clothing and footwear for the event and weather.

Accessibility

I acknowledge it is my responsibility if I choose to bring a wheelchair/pram. Due to the terrain of the route, we suggest participants refrain from doing this.

Alcohol

I understand that I am responsible for my alcohol consumption and that the hospice is not responsible for any negligence or excessive drinking. The Walker Guide will include a list of suggestions regarding walking, eating, alcohol consumption and best practice. First aiders and medical teams will be present on the route to ensure safety in responding to any incidents or emergencies that may arise.

Please note, there is strictly no consumption of alcohol at the Humber Bridge Country Park car park, as instructed by the Humber Bridge Board.

Photography

We will have professional photographers at the event. By participating in the Pub to Pub Walk, you consent to your image being used in marketing, publicity and future advertising of the event.

Liability

I agree to abide to each of the headings and information outlined within this disclaimer.

I understand and agree that the organiser shall not be liable for death, negligence or breach of statutory duty, personal injury or loss or damage as a consequence of my participation, except with regard to personal injury arising as a result of the organiser's negligence.

I agree to refrain from damaging any third party property and in the event of this happening, accept that it is my responsibility to notify the event organiser and exchange details with the third party.
